

Family Law Attorney Fees

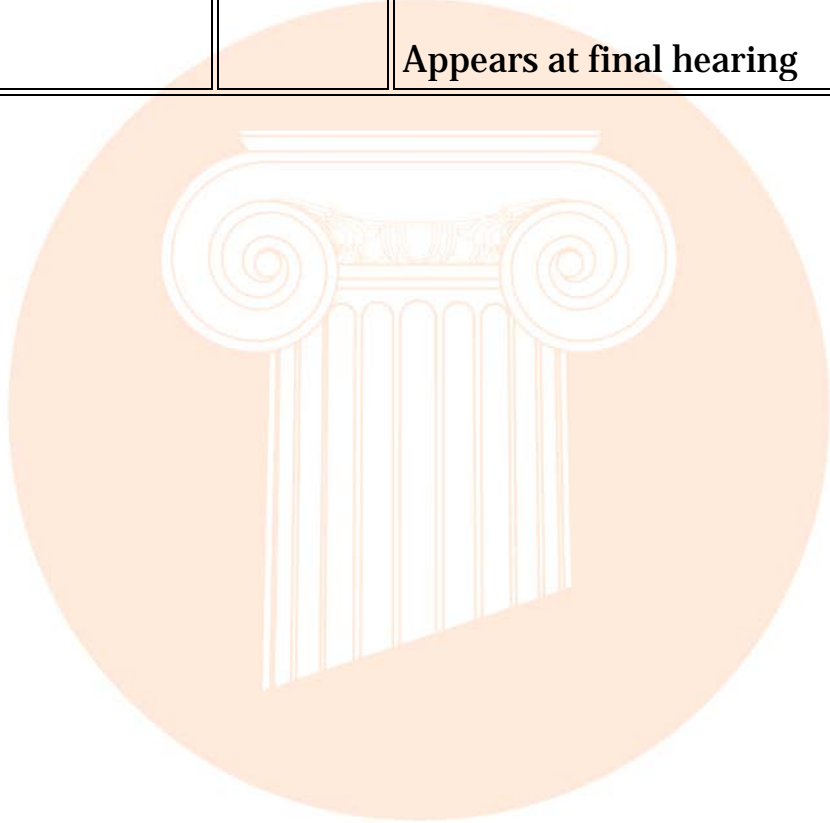
